WHEREAS, the Board of Directors for the Association passed a resolution setting forth the amount of a transfer fee to be imposed on new owners who enter into purchase contracts to purchase units within Springtree Condominiums, which is recorded as Document No. 2005-0314382 in the records of the Maricopa County Recorder's Office; and

WHEREAS, the Association wishes to establish the purpose and use of the Transfer Fee funds by enacting and recording this new Board resolution.

NOW, THEREFORE, the Board of Directors resolves as follows:

- 1. The Transfer Fee shall be used by the Association exclusively to supplement reserves.
- 2. The Board of Directors may change the use of the Transfer Fee by recording a subsequent Board Resolution.
- 3. This fee shall be in addition to any other fees and assessments due and payable at the close of escrow, including, but not limited to, any resale disclosure or transfer fee charged by the Association's management company.
- 4. The Board of Directors may hereafter change the amount of the Transfer Fee from time to time by written resolution.
