Additionally, with some new people in the community here are some other tips to keep the neighborhood a safe area:

Leave on all outdoor lights after it gets dark

A CAMPAIGN TO IMPROVE THE COMMUNITY

At its January meeting the Homeowners Association Board agreed unanimously to ask the community to amend the Homeowners Benefits and Assurances (HBAs). The HBAs were put in place more than 40 years ago and contain obligations and rules that are unworkable in the current community. Unfortunately, none of those obligations can be updated without the vote of 7/8ths of the homeowners. According to Board President Juan Acevedo, "To succeed we will need 100% community participation. Examples of provisions that need changing include prohibitions on working from home, limiting homeowners, in the Courthomes, to only one car that can be parked in the subdivision and an obligation to allow a community helicopter-landing pad!" To prepare for this important community vote please make sure Vision has your current US mail and e-mail addresses so your ballot arrives promptly.
