Trash pick-up: Monday & Thursday mornings between 2:00a-4:00a. Do not place your trash at the curb of the building you reside in until at least 6:00p the night before. There is a dumpster you can use at any time in Lot C. However – the *dumpster is not for bulk trash. Break down boxes* before using the dumpster. Don't place trash on ground next to it. NOTE: Due to heavy use and misuse of this dumpster by those inside and outside of our community, we are increasing the frequency of dumpster pickup to twice a week. This trial will last for a 30 day period. If misuse and overloading of the dumpster continues, the Association will have no choice but to terminate this courtesy dumpster service.

Recycle pick-up: Wednesday mornings between 2:00a-4:00a. Recyclable items include: cardboard, paper, plastic, glass and small cans. All containers must be washed out and clean before putting in the recycle bin. Unclean containers contaminate and leak, destroying any chance that anything in the bin can be recycled. *Also, do not bag your recyclables. If recyclables are bagged, the recycling company throws it in with garbage.

Pet Friendly Community: We love our pets! Please remember to keep dogs on leash. Use bags to pick up your pet's waste, and place in trash container. We have two locations for free waste bags, Belmont Ave & Frier – at the green space. The second is on Dreamy Draw Drive.

Pool area: No smoking in the pool area, no glass in the pool area and no pets in the pool area.

WHAT HAVE YOU DONE FOR ME LATELY? PCA Board – Activities for May 2021

- HBAs Update Project We are currently waging a community-wide campaign and operating the election to gather the votes necessary to lower the number of homeowner votes required to change our current HBA rules. With dedicated community volunteers, community members' contact information and neighborhood maps were updated to support the effort. To update your contact information, contact Vision directly. This month, we are conducting and monitoring the election to ensure full participation.
- Community Pool Remodeling Project After soliciting and reviewing bids from qualified vendors, we have awarded the contract, selected options within budget, and are monitoring contractor performance to ensure quality and an on-time delivery of a revitalized pool. Remodeling begins May 3rd.
- Common Area Improvements Revitalized plants, flowers, and community signage. Wash maintenance, cleanup, evaluation of African Sumac removal project and solicitation of community input for future action. Pool Leak Test also in progress. Regular, Ongoing Monitoring and Enforcement of Standards At the Board's direction and review, our property management company inspects visual elements within our community to protect our investments and ensure compliance with community rules.




Facelift in Progress - Major renovations include (but are not limited to):

Here are some tips to keep the neighborhood a safe area:


<u>Turn and Leave</u>all outdoor lights ON after it gets dark
