# FOURTH AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR TEMPE ROYAL PALMS VILLAGE

This Fourth Amendment to the Declaration of Covenants, Conditions and Restrictions for Tempe Royal Palms Villas ("the Amendment") is made as of this 26<sup>th</sup> day of July, 2010, by Villas Las Palmas, Inc., an Arizona nonprofit corporation (the "Association").

#### RECITALS

- A. The Declaration of Covenants, Conditions and Restrictions for Tempe Royal Palms Village (the "Declaration") was recorded on April 13, 1982 at docket 15954, page 1440 in the official records of the Maricopa County Recorder.
- B. The Declaration was amended by the First Amendment to Declaration of Covenants, Conditions and Restrictions for Villas Las Palmas recorded on September 13, 1982 at docket 16283, page 754 in the official records of the Maricopa County Recorder.
- C. The Declaration was amended by the Second Amendment to Declaration of Covenants, Conditions and Restrictions for Tempe Royal Palms Village aka Villas Las Palmas recorded on November 22, 1982 at docket 16437, page 879 in the official records of the Maricopa County Recorder.
- D. The Declaration was amended by the Third Amendment to Declaration of Covenants, Conditions and Restrictions for Tempe Royal Palms Village aka Villas Las Palmas recorded on June 17, 1983 at instrument number 83-235209 in the official records of the Maricopa County Recorder.
- E. The Declaration is silent as to amendment after the first 20 year term of the Declaration.
- F. Section 6.10 of the Restatement Third, Property (Servitudes) provides that the Declaration may be amended by members holding two-thirds of the voting power.
- G. This amendment was adopted and approved by members holding two-thirds of the voting power.

### **AMENDMENT**

NOW, THEREFORE, the Declaration is amended as follows:

Article I, Section 20 is deleted in its entirety and replaced with the following:

"Structural maintenance area" or "structural maintenance areas" shall mean the exterior building surfaces (structural walls only, excluding glass surfaces), trees, shrubs, grass, walks and other exterior improvements.

Except as expressly amended by this Fourth Amendment, the Declaration shall remain in full force and effect. In the event of any conflict or inconsistency between this Fourth Amendment and the Declaration, this Fourth Amendment shall prevail.
