SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM AND OF COVENANTS, CONDITIONS AND RESTRICTIONS FOR CAVE CREEK VILLAS, A CONDOMINIUM

This Second Amendment to the Declaration of Condominium and of Covenants, Conditions and Restrictions for Cave Creek Villas, a Condominium ("the Second Amendment") is made as of this 12 made as of this 1

RECITALS

- A. The Declaration of Condominium and of Covenants, Conditions and Restrictions for Cave Creek Villas, a Condominium (the "Declaration") was recorded on June 9, 2004 at Instrument No. 2004-0653384 in the official records of the Maricopa County Recorder.
- B. The First Amendment to Declaration of Condominium and of Covenants, Conditions and Restrictions for Cave Creek Villas, a Condominium (the "First Amendment") was recorded on June 16, 2004 at Instrument No. 2004-0683214 in the official records of the Maricopa County Recorder.
- C. Article 12, Section 12.5(A) of the Declaration provides that the Declaration may be amended at any time by a vote or written consent of the Unit Owners to which at least sixty-seven percent (67%) of the votes in the Association are allocated.
- D. This amendment was adopted and approved at a duly called election, the Unit Owners to which at least sixty-seven percent (67%) of the votes in the Association are allocated voting affirmatively for the adoption of the amendment.

AMENDMENT

NOW, THEREFORE, the Declaration is amended as follows:

The following language shall be <u>added to Article 5</u>, Section 5.0(A):

- (xi) the roofs of all Duplex Unit Groups and Triplex Unit Groups;
- (xii) the exterior paint on all Duplex Unit Groups and Triplex Unit Groups.

Except as expressly amended by this Second Amendment, the Declaration shall remain in full force and effect. In the event of any conflict or inconsistency between this Second Amendment and the Declaration, this Second Amendment shall prevail. Unless otherwise defined herein, each capitalized term used in this Second Amendment shall have the meaning given to such term in the Declaration.
