## CONTINUED AUTHORITY TO REGULATE PUBLIC ROADWAYS

WHEREAS, the Pineview Homeowners Association ("Association") is governed by the Declaration of Covenants, Conditions and Restrictions for Pineview, and recorded at Instrument No. 1992-0096505, records of Maricopa County, Arizona (the "Declaration) and any amendments thereto;

WHEREAS, the Final Plat for Pineview, recorded at Book 348 of Maps, Page 25, Official Records Maricopa County Recorder ("Final Plat"), dedicates certain streets within the community to the public;

WHEREAS, Arizona Revised Statute § 33-1818(B)(1) provides that "Not later than June 30, 2025, the planned community shall call a meeting of the membership on the question of whether to continue to regulate public roadways;

WHEREAS, the Members of the Association seek to continue and retain authority to regulate the public roadways within the community as set forth on the Final Plat and in connection with the provisions found in the Declaration;

WHEREAS, the Association held a duly noticed Annual Meeting of the Members on March 12, 2025, at which a quorum of Members entitled to cast at least ten percent of the votes of the Association were present;

WHEREAS, a majority of the Members at the Annual Meeting of the Members voted for the Association to retain authority over the public roadways within the community pursuant to the Final Plat and Declaration;

NOW, THEREFORE, the Association has met the necessary threshold as set forth in Arizona Revised Statute § 33-1818(B) and shall continue to have authority to regulate the public roadways in connection with and as set forth in the Final Plat and Declaration.
