



### Additional Parking

The Board of Directors has decided to add additional designated parking areas for residents at RSF on a **90 day trial basis**. The intent is to help residents that have a vehicle that cannot fit into the driveway or garage. No commercial vehicles of any type or size are permitted in these areas. Vehicles must be parked on the designated side of the street. The City states that vehicles may be parked in these areas as long as they abide by City regulations. Cars must be parked the right direction, must not exceed the parking time frame, and cannot be inoperable or abandoned. The proposed areas are below. If you would like to voice concerns with any of the proposed locations, please contact Vision Community Management. The Board will be discussing the parking areas at their next meeting to determine if these areas will remain designated parking areas.

- W side of N 127th Ave between Edgemont & Roanoke
- W side of N 127th Ave between Windsor & Cambridge
- W side of N 127th Ave between Virginia & Lewis
- Both sides of N 127th Way between Roanoke & Windsor
- E side of N 127th Ln between Wilshire Dr & Encanto Blvd
- W side of N 127th Ave north of Monte Vista to Palm Ln
- W side of N 125th Dr between Coronado Rd & Almeira
- W side of N 124th Dr between Palm Ln & Granada Rd
- W side of N 125th Dr between Edgemont & Roanoke
- W side of N 125th Dr between Windsor & Cambridge
- E side of N 126th Dr between Virginia & Sheridan
- W side of N 126th Ave between Cambridge & Virginia
- W side of N 123rd Dr between Lewis & Alvarado
- W side of N 123rd Ln between Wilshire & Vernon
- W side of N 123rd Dr between Virginia & Sheridan
